• SJEC Treasurer's Report:

Cash on hand as of Feb 18, 2025: Horizon Bank = \$186,000 before BNY \$57,000 monthly endowment deposit in mid-February 2025 with a target to keep a minimum of \$100,000 at Horizon. \$35,000 Organ Fund and \$25,000 Reserve Fund = \$60,000

Correct 2023 W2 withholding taxes and FICA = \$40,000

BNY Mellon Savings = \$112,000

Jan/YTD 2025 Financials (Revenue = \$75,000 vs. 93,000 (budget) and Expenses = \$98,000 vs. \$86,000 (budget)

Revenue = Member Revenue = \$17,000 vs. \$21,000 (budget) + Endowments = \$57,000 vs. \$70,000 (budget) + Other = \$400 vs. \$1,900 (budget)

Pledges \$4,000 below budget.

Endowment \$13,000 underspent – No Endowment Grants & Williams Flooring \$10,000 from checking.

- February's Second Sunday Sharing (SSS) was "Dismantling Racism". Angela Garcia was the facilitator and reported that it was a very positive meeting. Several people were interested in forming regular meetings, sharing experiences, recommending books, etc. The Vestry is setting up topics for the rest of the year. The March 9 SSS topic is for SAMS Pantry.
- Sunday Weather Cancellations: After discussions, it was determined that future cancellations due to dangerous weather conditions will go through the Vestry Wardens and Reverend Alissa.
- 2024 Parochial Report: The annual report for 2024 should be ready to be approved at the March 18, 2025 meeting.

- Rector's Report: Due to illness, etc., people have had to substitute for office personnel. Staff support needs to be addressed by the Vestry and/or the Wardens. Reverend Alissa is preparing a devotional for Lent, will be attending bay area clergy meetings, will be possibly be a member of the secretariat during the general convention (lasting ten days) in 2027, and is working with a couple that is interested in joining St. John's.
